RESERVATION AND PAYMENT POLICIES

Deposits are required to hold any reservation.

Individuals: \$50 deposit per person.

Private Charters: Half Day \$400.00, All Day \$600.00.

Full payment required 60 days prior to arrival for certain packages.

Reservations are not confirmed until proper payment is received.

All monies payable in Bahamian or U.S. currency.

MasterCard & Visa Credit Cards Accepted

Only Bahamian Cheques made payable to DiveTime are accepted

CHANGES TO RESERVATIONS

Changes to reservations, which have been paid in full with vouchers issued, incur a \$25 per person change fee.

Changes to any reservation inside of 7 days incur a \$25 per person change fee. All changes cause the itinerary to be re-priced at the current available pricing.

CANCELLATION AND REFUND POLICY

Prior to 15 Days Out - \$25 per person cancellation fee. (30 days for holidays)

15 Business Days Out – (M-F) \$50 per person cancellation fee plus applicable hotel penalty.

Inside of 24 hours of first activity, including No-Shows – Non-refundable.

Hotel penalties vary based on property.

Unused portion of any package plans not taken by customer's choice are non-refundable.

Pre purchased certification courses are valid for one year - Non-refundable.

Furthermore, DT reserves the right, without notice, to make changes or cancellation, in part or in whole, as circumstances dictate. DT accepts no liability for the consequences of the personal activities of any passenger who is deemed personally responsible for the decisions concerning conditions of health, safety or fitness for diving or any other activity, or any other circumstances beyond its control.

DT will not be responsible for, and will not issue refunds or credits for the following: early departure by customer's choice, dives cancelled as a result of inclement weather and /or acts of God; damages or cost resulting from postponed flight times, including but not limited to, missed transportation connections; nor for errors herein. Flight departure and arrival times cannot be guaranteed, as weather conditions may affect operating conditions.
